NOVEMBER 29, 2017 WEDNESDAY:

- REGISTRATION and ROUTINE PREVIEW FOR EARLY ARRIVALS available at select times throughout the day.
- Times will be included in information packet.

NOVEMBER 30, 2017 THURSDAY:

ARRIVE in Orlando, Florida!

- In order to receive airport transfers, flights must arrive into Orlando International Airport (MCO).
- PLEASE NOTE: Travel arrangements to Orlando are NOT INCLUDED in the cost of the performance package. Should there be flight delays or weather cancellations on arrival or departure days, we will be able to accommodate you better with tickets purchased through A&I Travel Management. A&I's phone number is 1-866-719-0379.
- REGISTRATION available throughout the day.
- EARLY ROUTINE PREVIEW also available this afternoon (times TBD).
- The ORIENTATION MEETING and FIRST REHEARSAL will be held at 5:00 PM. We recommend ARRIVAL to Disney's CORONADO SPRINGS RESORT no later than 3:30 PM.

DECEMBER 1, 2017 FRIDAY*:

- MORNING PRACTICE and PRE-PARADE PERFORMANCE GROUP 1.
- Enjoy the rest of the day at YOUR FAVORITE DISNEY PARK!

DECEMBER 2, 2017 SATURDAY*:

- PRE-PARADE PERFORMANCE GROUP 2.

**Performance Day is tentative, based off of your performance group and will take place either Friday or Saturday. Attendees will only perform one time.*

TOUR COST

TOUR COST, RESERVATIONS & PAYMENTS: The total number accepted for the tour is limited. Completed reservation application and \$150.00 (non-refundable) per person deposit **MUST BE RECEIVED** in the Varsity Spirit office on or before the dates listed below. You may fax in your registration forms to Varsity Spirit. However, **rooms are not guaranteed until deposits or a school purchase order has been received in the Varsity Spirit office.** (Deposits are credited toward your total cost.)

PARTICIPANT PRICES:

- Quad (4 persons per room), \$789.00 per person
- Triple (3 persons per room), \$843.00 per person
- Double (2 persons per room), \$933.00 per person
- Single rooms are not available for participants

SPECTATOR PRICES:

- Quad (4 persons per room), \$649.00 per person
- Triple (3 persons per room), \$709.00 per person
- Double (2 persons per room), \$789.00 per person
- Single (1 person per room), \$999.00

Pricing is based on the total number of people in a room regardless if they are a participant or a chaperone. For example, three participants and one chaperone in a room would be the quad rate. The participants would pay the participant quad rate and the spectator/chaperone would pay the spectator quad rate.

PAYMENT DEADLINES:

- If you attended camp in June, deposit deadline is July 12, 2017.
- If you attended camp in July, deposit deadline is August 9, 2017.
- If you attended camp in August, deposit deadline is September 6, 2017.

After September 6, please call the Varsity Spirit office for availability.

FINAL PAYMENT IS DUE IN THE VARSITY SPIRIT OFFICE ON OR BEFORE OCTOBER 2, 2017. UNIFORMS WILL NOT BE SHIPPED UNTIL THE BALANCE OF PAYMENT IS MADE.

PLEASE NOTE: If final payment is not received by October 2, 2017, and the special written arrangements are not made with Varsity Spirit PRIOR to the October 2 deadline, tour participants will automatically be removed from the tour, which will result in a complete forfeiture of all monies paid.

EXTRA NIGHTS: A limited number of rooms are available before or after the event at \$242 per ROOM per night. Please indicate if you wish to purchase an extra night. (Extra night fees are for room only. This does not change the 3-Day Walt Disney World® PARK HOPPER®.)

TICKET UPGRADE: You may add additional days to your 3-Day Park Hopper for \$35 per person per day. Please indicate on your rooming list if you wish to do this (up to 5-Day Park Hopper).

CHAPERONES: One (1) adult chaperone for every three (3) participants. Varsity is not responsible for supervising the participants.

CONFIRMATION: After completed reservation application and deposit are received, a reservation confirmation will be sent to you via email. Information regarding the performance and confirmed rooming list will be sent to you in late September. A link with your routine and your uniform will be sent to you two weeks prior to the event.

CANCELLATIONS AND REFUNDS: For cancellations received before September 6, 2017, all monies will be refunded with the exception of the \$150.00 per person deposit. For cancellations made between September 7, 2016 and October 2, 2017, an additional \$100.00 per person penalty will apply to cover entertainment guarantees.
